Management's discussion of fund performance

The fund's Class R-6 shares gained 2.76% for the year ended July 31, 2026. That result compares with a 2.16% gain for the Bloomberg Municipal Short 1-5 Years Index.

What factors influenced results

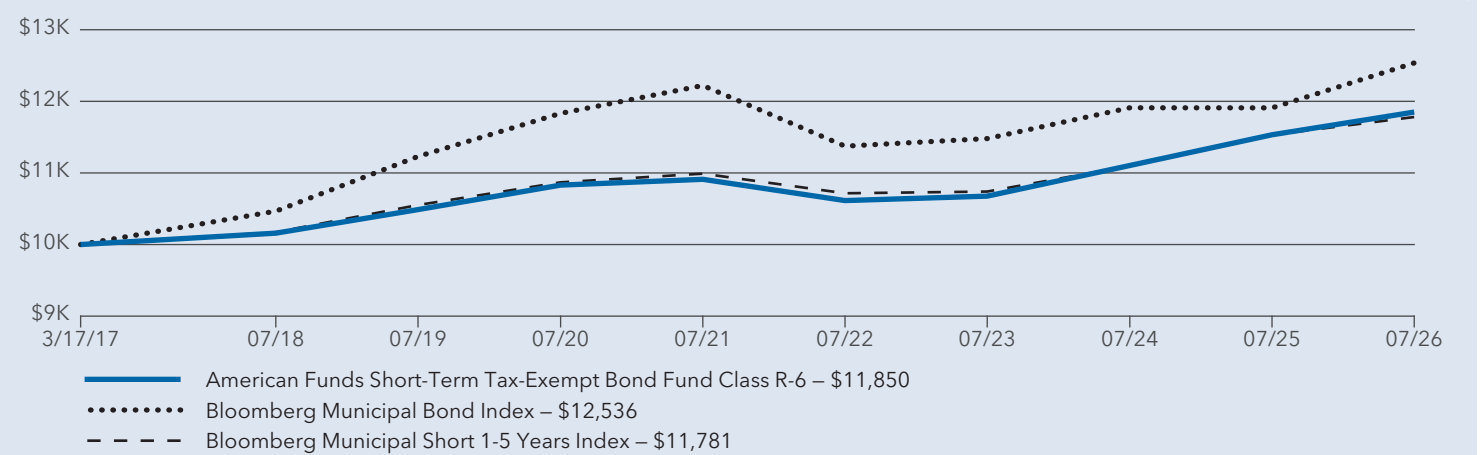
During the fund's fiscal year, municipal bonds posted positive returns. The U.S. economy remained resilient, though signs of labor market softening led the U.S. Federal Reserve to implement three 25-basis-point rate cuts. Interest rate volatility drove returns while credit spreads remained range-bound. The municipal yield curve remained steep, as demand for shorter maturities was consistently strong.

Both the fund and benchmark (the Bloomberg Municipal Short 1-5 Years Index) generated positive absolute results over the period. Interest rate positioning and sector allocation were the primary contributors to relative results. Security selection contributed to a lesser extent. Yields on the municipal curve rose on the short end of the curve and fell on the long end. The fund was modestly long duration (0.04 years on average) relative to the benchmark. The fund was overweight the 5- and 10-year segments of the curve and underweight the 2-year part of the curve. From a sector perspective, overweights to housing and corporate bonds contributed to relative results. An underweight in the general obligation sector contributed as well. Security selection within the education sector was particularly additive. Investment choices in special tax and transportation bonds also contributed.

Conversely, security selection within the corporate sector detracted.

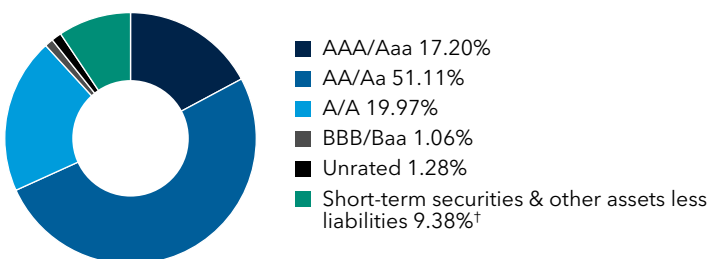
