# Tax-exempt income

The Tax-Exempt Bond Fund of America seeks to provide income that is exempt from federal – and in some cases state – income taxes. To match its 12-month 3.10% tax-exempt distribution rate as of 7/31/25, investors in the 40.8% tax bracket would have to earn a taxable rate of 5.24%.\*

# Thorough analysis


To find investments for the fund, we rely on the extensive proprietary research efforts of our portfolio managers, analysts, economists and traders. We combine top-down analysis of macroeconomic, political and monetary forces with in-depth, bottom-up research on individual securities and issuers.

### Diversification with no AMT

As of its fiscal year-end on 7/31/25, the fund owned bonds from approximately 1,507 issuers in 50 states, three U.S. territories and one federal district. The fund doesn't invest in bonds subject to the alternative minimum tax (AMT).


