The funds invest in underlying American Funds Insurance Series funds that are aligned to help investors pursue retirement goals such as accumulating assets, planning an income strategy or preserving capital.

### Fund information

#### Objective

To provide long-term growth of capital while seeking to manage volatility and provide downside protection.

#### Distinguishing characteristics

The fund pursues its investment objective by investing in shares of underlying American Funds Insurance Series funds, while seeking to manage volatility and provide downside protection primarily

through the use of exchange-traded options and futures contracts.

<sup>2</sup> Maximum drawdown is the largest peak-to-trough decline measured for the fund, the comparable index and the S&P 500 Index since the fund's inception date of May 1, 2015.

<sup>3</sup> Annualized standard deviation (based on monthly returns) is a common measure of absolute volatility that tells how returns over time have varied from the mean. A lower number signifies lower volatility.

<sup>4</sup> Sharpe ratio is calculated by Capital Group based on Morningstar data. It uses standard deviation and return in excess of the risk-free rate to determine reward per unit of risk. The higher the number, the better the portfolio's historical risk-adjusted performance.

<sup>5</sup> Cash and equivalents in support of the managed risk strategy and hedge instruments. Cash and equivalents in support of the managed risk strategy includes short-term securities, accrued income, Treasury futures and other assets less liabilities. Hedge instruments are primarily exchange-traded put options and futures contracts.

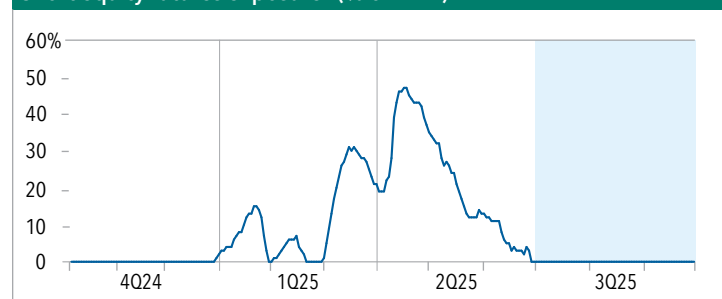

### Short equity futures exposure

Short equity futures exposure measures the notional amount of exchange-traded equity futures that the fund is invested in, expressed as a percent of the fund's net asset value.

### Quarterly review

U.S. stocks rose steadily, bolstered by strong corporate earnings, lower interest rates and a resilient economy. The communication services and information technology sectors led markets higher. The rally was broad-based, with only the consumer staples sector declining. Overall, the S&P 500 Index advanced 8%, reaching several new all-time highs during the quarter.

The U.S. bond market produced solid results in the second quarter, as the Federal Reserve held interest rates steady as it awaited further clarity on the outlook for U.S. growth and inflation.

The VIX (volatility index) decreased from 18.7 to 17.6 during the quarter, in line with 18.8

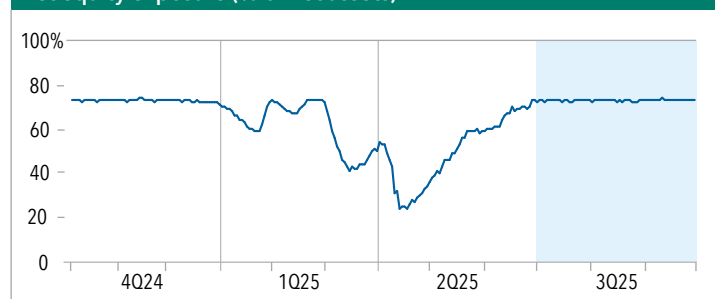
