Dividend opportunity

As of 6/30/23, the fund's 12-month distribution rate of 2.88% was higher than the 1.82% rate of the Lipper International Funds Average, the fund's peer group. The fund's annualized 30-day yield as of 7/31/23, calculated at maximum offering price in accordance with the Securities and Exchange Commission formula, was 2.29%*.


For investors, the fund's dividend focus:

- Offers an opportunity to receive regular income with the possibility of gains in the underlying stocks.
- Can help reduce volatility because dividends may continue to be paid even when the price of a stock declines.

The fund's solid start

The fund commenced operations in October 2008. As the chart shows, the fund has had lower volatility and a higher return than its benchmark, the MSCI All Country World Index (ACWI) ex USA.


