Distinguishing characteristics:

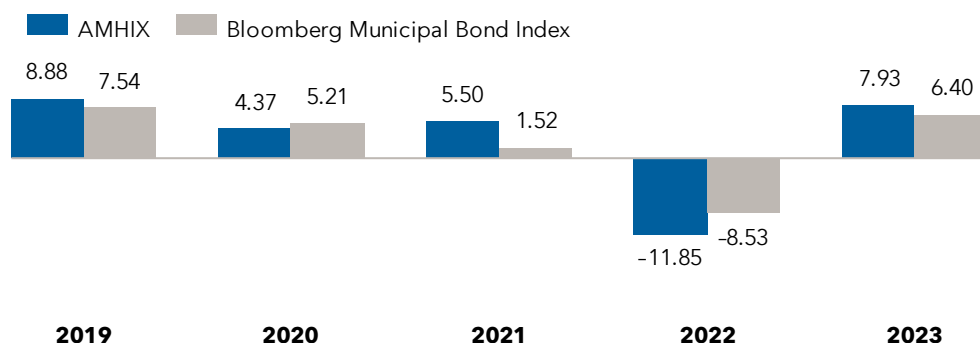
